HEATS:

Heats will be arranged well before the event and posted as soon as possible.

JUDGING AND SCORING:

The skimboarder who completes the most radical, controlled maneuvers, in the most critical section of the biggest and/or best waves, for the longest functional distance, will earn the highest scores. The competitors will be judged on their top 5 rides. Scores are totaled and riders ranked 1 to 4 by each judge, then 3 judges rankings are totaled lowest total wins.

Example: (three 1sts = 3) (three 4ths = 12) (one 2nd + two 3rds = 8). We will be using 3-5 judges this year.

CUTOFF PENALTY:

Waves belong to the FIRST rider to clearly maneuver into position closest to the curl, or signal his intentions, verbally or otherwise. The rider guilty of a cutoff could lose his/her highest scoring ride off the total score from each judge. Risk a cutoff and risk the heat as the rules will be strictly enforced.

HEATS:

Year 2008 was revolutionary in the fact that we were able to run Man-on-Man heats. This format is well suited for the break at Lover's Beach and we will do our best to replicate that scenario this year. The heats will be arranged and seeded in advance with the most experienced skimmers spread out as far apart as possible. The highest scores will advance.

Contestants should plan to be at the beach for TWO FULL DAYS. If you are not there when your heat is called, you will be disqualified.

No promotional banners or tents allowed except for Official Contest Sponsors.

Awards will be at a location TBD after the final day of the event.
